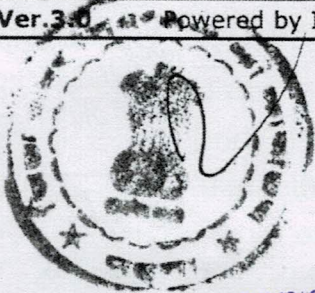

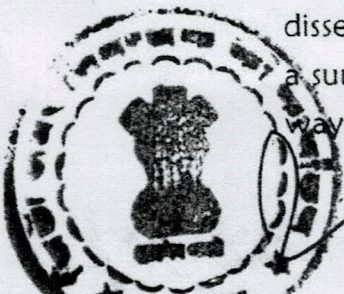

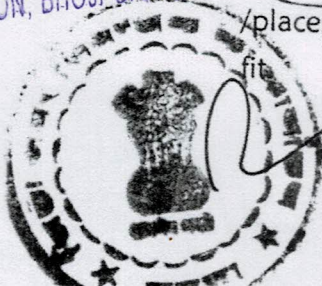

3. TRUST FUND:

- I. The Trustees hereby declare that they and the survivor of them or other trustees or trustee hereof for the time being will hold the said sum of Rs. 51,000/- (Fifty One thousand only) made over by the settler to the trustees as aforesaid and all gifts, contributions, subscriptions, donations, bequests and other moneys or property as and when the same shall be paid to or vested in them and the moneys investments and properties from time to time representing the same upon trust to apply the same or the sole purpose and advancement of education and social welfare not involving the caring of any activity for profit in the territories of India, PROVIDED HOWEVER, no part of the fund income thereof be applied to any purpose outside India without permission of the appropriate authority as per law.
- II. The trustees have taken charge / possession of the said of Rs.51,000 (Fifty One thousand only) which will from the corpus of the trust, and it shall not be disposed of or subjected to any kind of charges for the purposes of meeting the expenses or for carrying out the objects of the trust.

4. OBJECTS: The objects for which the trust is founded are

- I. To establish, maintain and run schools, ply schools, colleges, social service centres, industrial training centre either under ownership or through franchisee basis.
- II. To establish, training centre, and allied education institutions.
- III. To establish, cultural, and social institutions.

- IV. To spread for promotion of education and learning in all branches more specifically in Arts, Science and Commerce.

Provided always that it is hereby expressly declared than if at any time during the subsistence of this trust any of the objects herein contained / herein before stated is construed to be not wholly for public charitable purposes within the meaning of the Income Tax Act 1961 such one or more objects shall be deemed to have never been stated / existed and / or included in the object clauses of this trust and the validity of the trust created by these presents as a trust for public and charitable purposes shall not be affected in any manner.

The trust shall be an irrevocable public educational trust for the benefit of all persons belonging to whatever community irrespective of caste, creed or religion. The Trustees shall stand possesses of the said amount of corpus endowed by the settler of the trust and such other properties (both movable and immovable) as may be acquired from time to time by the trust by purchases, exchange, grant, allotment subscription, endowment, donation, contribution, or in any manner to whatsoever (all of which shall be designed as trust properties) on the trust herein mentioned.

5. NUMBER OF TRUSTEES/ APPOINTMENT OF TRUSTEES:

- I. The Trust shall be governed by a board of trustees. the number of trustees including the settler of the trust shall not be less than three and not more than eleven persons at any given point of time. It is being expressly declared that the trustees mentioned above (including the settler) shall be founder trustees and shall hold office for life.

- II. The first of the three trustees including the settler shall hold office for life. And that any of the trustee out of the said remaining trustees may resign or retire or may be removed by the board of the trustees.

- III. Any trustee may resign by giving notice in writing within a notice period of 60 days to his co-trustees and shall also cease to be a trustee if requested in writing by three-fourths of the remaining trustees or the number nearest thereto.
- IV. Appointment of trustee either to fill up a vacancy or as additional trustee shall be on resolution of the trustees. The board of trustees shall nominate and invite person / persons to be the other trustees for such period, as they may fit and proper.
- V. In case of death, disability, insanity, removal, relegation or refusal on the part of the any of the trustees to act as such the vacancy so created shall be filled in by the decision of three fourth majority of the remaining members of the board of trustees.
- VI. The trustees who are not the first/ founder trustees shall hold office for a period of one year from their date of appointment by the trustees. At end of this one year period, the board of trustees may re-appoint them for subsequent term or appoint other persons as trustees in such a manner that the total number of trustees does not exceed the approved maximum numbers of trustees.

(6) MANAGEMENT

- I. For the management and administration of the trust, the trustees shall elect one amongst themselves for each of the offices of President, Secretary and Treasurer. No trustee shall hold more than one of the above offices of the same time.
- II. The President, Secretary and Treasurer shall hold office for their lifetime.
- III. After the demise or relinquishment of office of the above office-bearers, his/her legal heir shall be the successor to hold office, the remaining trustees shall elect such legal heir to act as President, Secretary or Treasurer, whatever the case may be. (7) PRESIDENT

(10) VACANCIES:

Any vacancy among the members of the board of trustees may be filled by the trustees as specified in Para (5) above or their successors and they shall hold office for such duration as may be specified by the board of trustees.

(11) TERMINATION OF OFFICE OF THE TRUSTEES:

A TRUSTEE shall cease to hold office:

- I. if he dies,
- II. If he resigns,
- III. If he is adjudged insolvent or found guilty of an offence involving moral turpitude.
- IV. If he is found to have acted against the interest of the trust.
- V. If it is unanimously decided by the founder trustees that his continuation in the office is against the interest of the trust.
- VI. Upon expiry of the period up to which the board of trustees have nominated the trustee;

whichever is earlier.

(12) MEETING AND PROCEEDING OF THE TRUSTEES:

THE TRUSTEES shall ordinarily meet once in 3(three) months or as often as may be necessary for the satisfactory conduct of the affairs of the trust. The Secretary may whenever he thinks fit or shall forthwith when directed by the president in writing to the secretary or upon requisition to secretary in writing signed by at least three fourth members of board of trustees, shall convene the meeting or

the board of trustees. In spite of such direction of the president or on such requisition of three fourth of the trustees, the secretary does not convene the meeting in 30 days of such direction or requisition, the president shall convene the meeting after expiry of the said 30 days but before 60 days of such direction or requisition.

I. NOTICE:

At least 5 days notice specifying the place, date, hour and agenda of the meeting shall be given by post, by hand or otherwise to all members of the board of trustees, however in case of any urgency, an emergent meeting may be called by giving shorter notice of less than 5 days.

II. QUORUM:

The trustees may from time to time frame rules for the conduct of the affairs of the trust and regulating the meeting of trustees, in the absence of such regulations:

a) All matters will be decided by majority. One third of the board of trustees or three trustees whichever is less shall form the quorum of a board of trustees meeting. If within 30 minutes from the appointed time for holding meeting the quorum is not complete, the meeting shall stand adjourned at same place and on the same day and hour of the next day and hour of the next week.

b) Resolution passed without any meeting of the trustees and evidenced in writing under the hands of three-fourths of the trustees shall be as valid and effectual as a resolution duly passed at a meeting of the trustees.

c) At all meeting of the board of trustees, the president shall take the chair. In case of his absence, the trustees present will elect one of them to be chairman of the meeting.

- d) Every question before a meeting shall be decided by a majority of votes of members present. In case of equality of votes, the chairman shall cast the deciding vote in addition to the vote he has as a trustee.

A minute book shall be kept by the trustee designated or authorized for the same. Minutes of entry into the office of every new trustee and of all proceedings of the meeting of the board of trustees shall be entered in the minute book and shall be signed by the chairman of the Meeting.

13. POWERS, FUNCTIONS AND DUTIES OF THE TRUSTEES:

- a) All property of the trust movable or immovable or of any other kind, shall vest in trust, the trustees shall manage the whole property and affairs of the trust and shall have all powers, duties and functions necessary proper and incidental to the promotion and carrying out of the trust.

- b) In particular and without prejudice to the generality of the foregoing the trustees shall for the purposes of this trust have the following powers, duties and functions:

- I. To acquire by the gift, purchases, exchange, ~~lease or otherwise~~, lands, buildings, or other immovable properties and also any movable property.
- II. To construct and maintain buildings, to alter, to demolish or improve them and equip them suitably.
- III. To accept gifts, donations, endowment and contributions for the trust and shall be treated as the income of the trust.
- IV. To raise loans, to receive monies, securities or other movable property on behalf of the trust.

- VII. To enter into contracts, or enjoyments on behalf of the trust.
- VIII. To consider such proposals submitted by sub committee appointed by this trust and allocate such funds if necessary as deemed necessary for the implementation of the programs.
